World Bank Loan : Sanctioned for EDFC-1 and applied for EDFC-3 Project

1. The Dedicated Freight Corridor Corporation of India Ltd. (DFCCIL) has received a Loan towards the cost of Eastern Dedicated Freight Corridor Project - EDFC-1 and has applied for Loan from the International Bank for reconstruction and development (IBRD) towards the cost of Eastern Dedicated Freight Corridor Project EDFC-3. EDFC intends to apply part of the funds to cover eligible payments under the contract for Civil Structure and Track Works Contract Package no. 301 & 302 from EDFC 3 and EDFC 1 respectively. Bidding will be conducted through the Bank's, "Guidelines under IBRD Loans and IDA Credits & Grants by World Bank Borrowers" (January 2011) revised July 2014. ICB will be conducted through the Bank's Two – Stage Bidding Procedure, comprising un-priced First Stage Technical Proposals and Second Stage Bids.
2. DFCCIL now invites un priced First Stage Technical Proposals from Pre – qualified/ conditionally pre qualified eligible bidders for the "Design and Construction of Civil, Structures and Track Works for Railway, involving Formation in Embankments/Cuttings, Ballast on Formation, Track Works, Bridges, Structures, Buildings, Yards, Integration with Indian Railways' existing Railway System and Testing & Commissioning on Design-Build Lump Sum Basis for Sahnewal-Pilkhani (approximate 175 route km of single line) and Dadri-Khurja (approximate 46 route km of double line) Sections of Eastern Dedicated Freight Corridor, Contract Package nos. 301 & 302.
3. Bidding documents for each contract package may be purchased by interested pre – qualified bidders on submission of a written application to GGM/P/EC at the address mentioned in Para 3 above and upon payment of a non – refundable fee of INR 50,000.00 (including VAT) on all working days from 1000hrs. to 1700hrs with effect from 29.06.2015. Alternatively bidders may download the document from the web site of DFCC (www.dfccil.gov.in) and submit a Banker's Cheque/ Demand Draft of INR 50,000.00 for each package in favor of "Dedicated Freight Corridor Corporation of India Limited "payable at New Delhi, along with their submission of First Stage Technical Proposals.
5. Pre Bid Conference will be held at the place and time determined in the BDS; ITB Clause 7.4. Bidders are invited to submit proposals as per the details mentioned in the Bid documents.
6. First Stage Technical Proposals must be delivered to the above office on or before 1500hrs on 26.08.2015. All pages of submittal shall bear signatures of the authorized representative of the Bidder.

First Stage Technical Proposals will be opened in the presence of bidder's designated representatives, who choose to attend at 1530hrs. on 26.08.2015 at the office of "Dedicated Freight Corridor Corporation of India Limited, Metro Station Building Complex, Pragati Maidan, 4th Floor, Conference Hall, New Delhi – 110 001". Second Stage Bids will also be opened in the presence of bidder's designated representatives who choose to attend at the future date and time to be specified in the Letter of invitation to submit Second Stage Bids.
