



## Invitation for Bid (IFB)

1. Dedicated Freight Corridor Corporation of India Ltd. (DFCCIL) has received a Loan from the International Bank for Reconstruction and Development (IBRD) towards the cost of Eastern Dedicated Freight Corridor Project – II and intends to apply part of the funds to cover eligible payments under the contracts for Electrical Works Contract Package CP-204. Bidding will be conducted through the Bank’s “Guidelines under IBRD Loans and IDA Credits & Grants by World Bank Borrowers” (January 2011). ICB will be conducted through the Bank’s Two – Stage Bidding Procedure, comprising un-priced First Stage Technical Proposals and Second Stage Bids.
2. DFCCIL now **invites un-priced First Stage Technical Proposals from Pre-qualified eligible bidders** for the “**DESIGN, SUPPLY, CONSTRUCTION, INSTALLATION, TESTING AND COMMISSIONING OF 2X25 KV, 50 HZ, AC TRACTION ELECTRIFICATION AND ASSOCIATED WORKS OF RAILWAYS LINES ON A DESIGN BUILD LUMP SUM BASIS FOR MUGHAL SARAI – NEW BHAUPUR (excl.) SECTION OF EASTERN DEDICATED FREIGHT CORRIDOR**”, **Contract Package CP 204**.

Alternatively bidders may download the document from the website of DFCCIL ([www.dfccil.gov.in](http://www.dfccil.gov.in)) and submit a **Banker’s cheque/demand draft of INR 50,000/- or US\$ 1000 in favour of “Dedicated Freight Corridor Corporation of India Limited”, payable at New Delhi, along with their submission of First Stage Technical Proposals**.
5. **Pre Bid Conference** will be held at the place and time determined in the BDS; ITB Clause 7.4. Bidders are invited to submit proposals as per the details mentioned in the Bid documents.
6. **First Stage Technical Proposals must be delivered** to the above office on or before **15:00 hrs. on 05.06.2015**. All pages of submittal shall bear signatures of the authorised representative of the Bidder.
7. **First Stage Technical Proposals will be opened** in the presence of bidder’s designated representatives who choose to attend, at **15:30 hrs. on 05.06.2015** at the office of “Dedicated Freight Corridor Corporation of India Limited, Metro Station Building Complex, Pragati Maidan, 4th Floor Conference Hall, New Delhi- 110001”.
