Dedicated Freight Corridor of India (DFCCIL) is a schedule 'A' Public Sector Undertaking under the administrative control of Government of India (Ministry of Railway). DFCCIL has been created to create and operate the most ambitious and biggest ever project in infrastructure sector, set-up to give economy a boost and build high capacity and high speed rail freight corridors along the golden quadrilateral and its diagonals. The first Phase comprises of construction of two Dedicated Freight Corridors spanning the Mumbai-Delhi (Western DFC) and Delhi--Kolkata (Eastern Corridor) DFC.

2. DFCCIL requires dynamic, experienced, and result-oriented retired senior level Govt. /PSU officers for re-engagement as **Advisor/Renewable Energy for Solar System Works** with HQ at Corporate Office/DFCCIL. ### 3. Terms of Reference (TOR):

- I. Study the feasibility of having solar panel system in vacant land and on roof tops of buildings in Corporate Office Complex, Noida.
- II. Study the feasibility of solar system along the track.
- III. Study the feasibility of other renewable energy options in other locations i.e. OCC/Ahmedabad, OCC/Prayagraj and Station areas etc.

- 3.2. The above re-engagement will be for DFCCIL project with HQ at Corporate Office, DFCCIL who would study the items mentioned in the TOR and share his experience and expertise on the subject through monthly reports under the above TOR heads.
- 3.3. The important terms and conditions of re-engagement and how to apply are mentioned as under:
