The Government of India, Ministry of Railways have applied for a loan from the Japan International Cooperation Agency (JICA) toward the cost of the Western Dedicated Freight Corridor Project and it intends to apply part of the proceeds of this loan to payments under the Loan Agreement No. ID-P229. The Dedicated Freight Corridor Corporation of India Limited (DFCC) intends to prequalify contractors and/or firms for Design, Supply, Installation, Testing and Commissioning work of Electrical and Mechanical works contract package (EMP-16) from JNPT to Makarpura (Vododara) WDFC-Phase-2.

It is expected that invitations for bid will be made in **January 2015**.

Description of Works: The Dedicated Freight Corridor Corporation of India Limited (DFCCIL) (hereinafter referred to as “the Employer”) intends to prequalify contractors and/or firms for Electrical and Mechanical Contract Package EMP-16.

It is intended to carry out the work of “Design, Supply, Installation, Testing and Commissioning of 2X25KV overhead Equipments, Traction sub-stations, auxiliary stations, Switching stations, Auto Transformer Stations and SCADA System on Design-build lump sum price basis for JNPT- Makarpura (Vododara) section (Approx. 422 Kms) of Western Dedicated Freight Corridor (Phase-2)”.

Prequalification will be conducted through prequalification procedures specified in the Guidelines for Procurement under Japanese ODA Loans, March 2009. Further, Eligible Nationality for an Applicant and all partners constituting the Applicant shall be the following;

- (a) Japan in the case of the prime contractor; and
- (b) All countries and areas in the case of sub-contractor(s).

Further, with regard to the above, in case where the prime contractor is a joint venture, such joint venture will be eligible provided that the nationality of the lead partner is Japan, that the nationality of the other partners is Japan and/or India and that the total

share of work of Japanese partners in the joint venture is more than fifty percent (50%) of the contract amount

Interested eligible Applicants may obtain further information from and inspect the Prequalification Documents at the address given below, from 11:00 to 17:00 hours (Indian Standard Time) on business working days during **26th September 2014 to 24th October, 2014.**

The prequalification document will be available for the sale from **26th September 2014 to 11th November, 2014** up to 1200 hrs in the office of DFCCIL at the address given below. A complete set of the prequalification document in English may be purchased by interested applicants on the submission of a written application to the address below and upon payment of a non-refundable fee of Rs. 12,000/- or US \$200+5% VAT. The method of payment will be through Demand Draft or Banker's Cheque drawn in favour of Dedicated Freight Corridor Corporation of India Limited, payable at New Delhi. Prequalification Document will be available at the address given below with CD-ROM including Forms in Microsoft Word version at the cost of Rs. 12,000 or US \$200 (Rs. Twelve thousand only) + 5%VAT. The prequalification document with CD-ROM can be obtained from the office of DFCC in person during 11:00 hrs. to 17:00 hrs on any working day on above dates. However, on 11th **November, 2014** it would be available only up to 12:00 hrs. If the applicant desires that the document be sent by post/ courier service, then an additional charge of Rs. 1000/- for inland delivery and Rs. 6000/- or US \$ 100 for overseas delivery shall also be paid along with the fee stated above. The request for sending prequalification application by post/ courier service must be received in the office of DFCCIL with requisite fee before **24th October, 2014.** PQ Document in PDF file will be available in Home Page of DFCCIL as shown below.

If the document is downloaded from website the Applicant must deposit the non refundable fee of Rs.12,000/- or US \$200 + 5% VAT as stated above with the Application, failing which the Application shall be summarily rejected.

Applications for prequalification should be submitted in sealed envelopes, delivered to the address below by 15:00 hrs of **11th November, 2014** (Tuesday) and be clearly marked "Application to Pre-qualify for ICB No. EMP-16: Electrical and Mechanical works Contract Package (EMP-16) from JNPT to Makarpura (Vododara) WDFC-Phase-2".
