3.1 DFCCIL may issue addendum(s)/corrigendum(s) to the tender document. In such case/s, the addendum(s)/corrigendum(s) shall be uploaded on DFCCIL's website www.dfccil.gov.in e-tender portal www.tenderwizard.com/DFCCIL at least SEVEN (7) days in advance of date fixed /re-fixed for closing of bids.
