QUALIFICATION REQUIREMENTS FOR BIDDERS- Tenderer shall meet with the minimum eligibility criteria for the work as detailed under-

- (i) The bidder should have completed supplying of Manpower & security services **for** a minimum value of **Rs.23.33 lakh (i.e.35%)** in the last three financial years (i.e. current financial year and three previous financial years) i.e. financial years 2013-2014, 2014-2015 & 2015-2016 (upto date of opening of tender).

Tenderer must submit the documents/certificates of the completed works from State/Central Govt. Organizations/ PSUs in support of information submitted above. The certificates from private individuals for whom such works are executed/being executed shall not be accepted.

- (ii) The total contract amount received by the bidder during the last three financial years and in the current financial i.e. financial years 2013-2014, 2014-2015 & 2015-2016 (upto date of opening of tender) should be minimum of **150%** of advertised tender value of the work i.e. **Rs.99.99 lakh.**
- (iii) Tenders must submit the audited financial statements/ documents/certificates in support of information submitted, failing which his/ their offer may be rejected without any correspondence with the tenderers at the sole discretion of DFCC.
