I. COMPANY PROFILE

Dedicated freight Corridor Corporation of India (DFCCIL) is a special-purpose vehicle set up under the administrative control of the Ministry of Railways to undertake planning & development. Mobilization of financial resources and construction, maintenance and operation of the Dedicated Freight Corridors. DFCCIL- was incorporated in October 2006 under the Indian Companies Act 1956 to carry on the business in respect of Planning, designing, development, construction, manufacturing, assembling fabricating, processing, installing, maintenance and operation of heavy haul freight railway infrastructure and related logistic support systems of all types and descriptions of India and abroad of rail-based goods traffic as may be approved by the Government from time to time and to undertake any or all activities connected thereof. (As per III (A)(I) of Memorandum of Association of the Company).

The Company has 2558 regular employees (Executives: 1196. Non-executives: 1362) as on 31 .03.2024.

The authorized and paid up capital of the Company is Rs. 22000 crore and Rs.15729 crores respectively as on 31.03.2024.

The Shareholding of the Government of India in the Company is 100% as on 31.03.2024.

II. JOB DESCRIPTION AND RESPONSIBILITIES

"Director(PP)" is a member of Board of Directors and reports to the Managing Director. He/She is responsible for the efficient functioning of the Corporation for achieving its corporate objectives and performance parameters.

"Director(PP)' has the overall responsibility for delivering DFC as per time bound program and completing various activities viz procurement of works, contract administration, project

procurement, coordination with various State Governments, Ministries and other public authorities. Director(PP) will also be involved in the planning of new corridors and DPRs for the project(s) allotted to him including the activities for execution of such project(s) as allotted to him.

In addition, Director (PP) will be responsible for ensuring the safety and security of project sites, personnel and assets, overseeing the efficient management of materials required for project implementation/ maintenance, including procurement, storage, and distribution and providing administrative support to the organization.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and not in a contractual/ad-hoc capacity – in one of the followings:-

3. QUALIFICATION:

The applicant should be an Engineering graduate with good academic record from a recognized University/Institution.

Applicants with MBA/ PGDM qualification will have added advantage.

4. EXPERIENCE:

The applicant should have at least five years of cumulative experience/ exposure in project planning/ management during the last ten years in an organization of repute.

Experience in Railway Sector, particularly mega construction projects and general management is desirable.

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- **4.** In the above cases, no request for relaxation or otherwise would be entertained.
