1.0 **GENERAL**

- 1.1 This is a contract having examination of the Device, identification and replacement of defective parts, and calibration. Award of the Contract does not confer any right to any of the individuals involved in this contract either directly or indirectly for a perpetual employment in DFCCIL in any capacity. The agency / service provider / Contractor/Supplier shall be entirely responsible for the employment of its labour and shall be liable for observance of all statutory provisions. No claim of employment by the manpower engaged on the DFCCIL on whatsoever ground shall be entertained.
- 1.2 This contract is of temporary nature. DFCCIL shall have discretion to change the scope of work of contract as per the requirement.

2.0 Validity

- The Contractor/Supplier shall to ensure the proper supply of items as per requirement of 2.1 contract.
- The contract shall be valid for a period of 90 days from the date of opening of Quotation 2.2 unless specifically extended in writing by the DFCCIL Administration on written request of the Contractor/Supplier.
- The time of extension may be considered if the delay is not attributable to the 2.3 Contractor/Supplier.
- DFCCIL Administration reserves the right to terminate the contract by giving 7 days' 2.4 notice in case DFCCIL Administration desires to have its own arrangements.
- DFCCIL Administration also reserves the right of termination of the contract with 2.5 immediate effect at any stage of time. This will apply when the agency fails to abide by / comply with the special terms and condition(s) and / or the agency has not been able to follow or comply the laws of statutory provisions of Central / State Government in force or has / have breached any contract agreement condition.

3.0 Liability against risks / claims:

3.1 DFCCIL Administration shall not be responsible for any injury or loss of life or sickness of the workmen or of any individual involved in the contract (deployed by the agency / service provider / Contractor/Supplier) during the course of their duties or out of their duty hours. Any statutory liabilities which may arise shall be on the agency / Contractor/Suppliers (s) / service provider's account

Signature of Quotationer

- 3.2 The agency / service provider / Contractor/Supplier (s) shall be solely responsible for the compliance of statutory regulations applicable to Contractor/Supplier labour as also other Central and State Government Statutory regulations associated with works such as provision of Minimum Wages Act, 1984, the Work Men Compensation Act, 1923 etc. No liability whatsoever shall attach to the DFCCIL on account of or any failure on the part of the agency / service provider / Contractor/Supplier (s) to observe these regulations.
- 3.3 Contractor/Supplier will be responsible for compliance of all statutory laws in force at Contractor/Supplier own cost.
- 3.4 Quoted rates are inclusive of all Taxes, royalties, transportation etc. (Excluding GST). No claim whatsoever of any nature shall be entertained.

4.0 Rates:

- 4.1 The rates quoted and accepted by DFCCIL shall be firm and final during the currency of contract.
- 4.2 All statutory taxes (Including GST) and liabilities levied / livable by the Central & State Government or any other governing authority / agency / from time to time shall be borne by the Contractor/Supplier and the rate shall be inclusive of all such liabilities.
- 4.3 All statutory deductions shall be made from bills as applicable as per DFCCIL/Govt. norms on such works.

5.0 SPECIAL CONDITIONS:

- 1. This is a works contract like all other works contracts awarded by DFCCIL. Award of the Contract does not confer any right to any of the individuals involved in this contract either directly or indirectly for a perpetual employment in DFCCIL in any capacity. The agency/service provider/contractor shall be entirely responsible for the employment of its labour and shall be liable for observance of all statutory provisions. No claim of employment by the manpower engaged on the DFCCIL on whatsoever ground shall be entertained.
- 2. The contract shall be valid for a period of 90 days from the date of opening of Quotation unless specifically extended in writing by the DFCCIL Administration on written request of the Contractor/Supplier.
- 3. The work will be executed under supervision of PM/Civil/JP or his representative.
- 4. The Contractor, after issue of the acceptance letter shall inform the PM/Civil/JP prior to start any execution work at the location.
- 5. The Contractor will ensure to take all safety measures during the execution of the work.

I. ADDITIONAL WORK

Engineer or representative of DFCCIL shall have the power to make any alteration, deletion, addition or substitution in the original scope and specification of work and no claim whatsoever on account of the above shall be entertained except for the payment for the actual work done on agreed rates for original items of the contract and negotiated and approved rates for new item.

II. QUANTITY VARIATION:

The DFCCIL reserves the right to vary, if required, the quantity of each item of work / supply up to 25% at the same rate and on the same terms and conditions. And also reserves the right to delete items if not required and subsequent cost against those items will be deducted from contract value.

III. TECHNICAL SPECIFICATION OF WORK

NS-I. Flash Butt Welding of 60 KG 90 UTS rails, conforming to IR's Manual for Flash Butt Welding of Rail, using contractor's self-propelled rail cum road. Mobile FBW Plants, tools, equipment's and consumables. Item also includes painting and marking of welded joints, pre-straightening & post-straightening of panels and USFD testing of finished weld as directed by engineer in-charge for - 60 KG on Cess" shall be executed as per manual for flash butt welding of Rails issued by RDSO/IRPWM/IR Guidelines / DFCCIL Manual / Direction of Engineer-in-Charge.

iv. PROTECTION OF TRACK DURING EMERGENCY

- (i) Action to be taken when a contractor's supervisor or vehicle operator apprehends unusual circumstances likely to infringe the track and endanger safe running of trains. At any time if a contractor's supervisor or vehicle operator observes any unusual circumstances likely to infringe the track and apprehend danger to safe running of track, he shall take immediate steps to advise a DFCCIL official of such danger and assist him in protection of track.
- (ii) The track shall be protected as under. One person shall immediately plant a red flag (red lamp during night) at the spot and proceed with all haste in the direction of approaching train with a red flag in hand (red lamp during night) and plant a detonator on rail at a distance of 600m from the place of obstruction of track after which he shall further proceed for not less than 1200m from the place of obstruction rom track and plant three detonators at 10m apart on rails. After this he shall display the red flag (red lamp during night) at a distance of 45m from the detonators. Attempts shall also be made to send an advice to the nearest DFCCI L station about the incident immediately.
- (iii) Action to be taken if the train is seen approaching to site of danger and there is no time to protect the track as per guidelines mentioned above. In such a case the detonators shall be planted on rails immediately at a distance away from place of danger as far as possible and attention of driver of the approaching train shall be invited by whistling, waving the red flag vigorously, gesticulating and shouting.
- (iv) Contractor will provide lookout men, The Contractor's Supervisors, Operators and lookout men shall be properly explained about the direction of trains on running tracks.

Signature of Quotationer

- 5.8 The Quotationer must sign Annexure-A, Annexure-B, and Annexure-C and submit them along with the quotation as a token of acceptance of terms and conditions. No changes will be entertained after the submission of the quotation.
- Payment will be made through RTGS. The agency must provide the required bank details. GST invoices should be raised in the name of Dedicated Freight Corridor Corporation of India Limited (GST No.: 08AACCD4768M1Z5).
- 5.10 The agency must submit copies of its PAN and GST registration to DFCCIL.
- 5.11 The Quotationer is advised to strictly adhere to the specified format and Special Conditions attached.

6.0 RATES TO BE ALL-INCLUSIVE:

The quoted rates shall include all statutory taxes (including GST) and liabilities imposed by the Central/State Government or any other governing authority, as applicable from time to time. The total quoted amount shall also include transportation, taxes, tolls, royalties, and statutory duties, all of which are to be borne by the Contractor. No claims in this regard will be entertained.

7.0 PERIOD OF COMPLETION:

The entire scope of work must be completed in all respects within 90 days from the date of issuance of the acceptance letter. Time is the essence of the contract. The Contractor/Supplier shall ensure steady and regular progress to complete the work within the stipulated time to the satisfaction of the Engineer.

8.0 SCHEDULE OF PAYMENT:

Payment will be made after inspection of the completed items mentioned in the Schedule of Quantities and upon finding them satisfactory by the Engineer-in-Charge.

9.0 QUANTUM OF WORK AND MATERIALS:

The indicative schedule of quantities for various items of work is detailed in Annexure-A of the tender documents.
