1.0 GENERAL CONDITIONS

- 1.1 This is a works contract like all other works contracts awarded by DFCCIL. Award of the Contract does not confer any right to any of the individuals involved in this contract either directly or indirectly for a perpetual employment in DFCCIL in any capacity. The agency/service provider/contractor shall be entirely responsible for the employment of its labour and shall be liable for observance of all statutory provisions. No claim of employment by the manpower engaged in this work on whatsoever ground shall be entertained.
- 1.2 This contract is of temporary nature. DFCCIL shall have discretion to change the scope of work of contract as per the requirement.

2.0 Validity:-

- 2.1 Contractor have to ensure the proper mobilization of resources and completion of work as per requirement of work.
- 2.2 The contract shall be valid for a period of 12 Month from the date of commencement of work. However DFCCIL has right to extend validity of work as per their requirement.
- 2.3 The time of extension may be considered if the delay is not attributable to the contractor.
- 2.4 DFCCIL Administration also reserves the right to terminate the contract by giving 7 days notice in case DFCCIL Administration desires to have its own arrangements.
- 2.5 DFCCIL Administration reserves the right of termination of the contract with immediate effect at any stage of time. This will apply when the agency fails to abide by / comply with the special terms and condition(s) and / or the agency has not been able to follow or comply the laws of statutory provisions of Central / State Government in force or has / have breached any contract agreement condition.

3.0 Liability against risks / claims:-

- 3.1 DFCCIL Administration shall not be responsible for any injury or loss of life or sickness of the workmen of any individual involved in the contract (deployed by the agency/service provider/contractor) during the course of their duties or out of their duty hours. Any statutory liabilities which may arise shall be to the agency / contractor(s) / service provider's account.
- 3.2 The agency / service provider /contractor(s) shall be solely responsible for the compliance of statutory regulations applicable to contractor labour as also other Central and State Government Statutory regulations associated with works such as provision of Minimum Wages Act, 1984, the Work Men Compensation Act, 1923 etc. No liability whatsoever shall attach to the DFCCIL on account of or any failure on the part of the agency/service provider/contractor(s) to observe these regulations.
- 3.3 Contractor will be responsible for compliance of all statutory laws in force at contractor own cost.

- 4.0 Rates:-**
- 4.1 The rates quoted and accepted by DFCCIL shall be firm and final during the currency of contract.
- 4.2 All statutory taxes (including GST) and liabilities levied / leviable by the Central & State Government or any other governing authority/agency from time to time shall be borne by the contractor and the rate shall be inclusive of all such liabilities.
- 4.3 All statutory deductions shall be made from bills as applicable as per DFCCIL/Govt. Norms on such works.

SPECIAL CONDITIONS OF CONTRACT AND SPECIFICATIONS: -

1. INTRODUCTION

It is proposed for Annual Maintenance Contract of water filter unit for 1 year (2024-25) in Rewari-Madar section under CGM Jaipur unit

2. DETAILED SCOPE OF WORK: -

Schedule-A

- (i) Annual Maintenance Contract of water filter unit for 1 year (2024-25) in Rewari-Madar section under CGM Jaipur unit.
- (ii) The rate includes complete maintenance of Water purifier system with RO and without RO.
- (iii) The AMC work includes complete job including transportation, labour and materials, all duties and taxes & taxes at the time of award.
- (iv) All leakage in supply line, replace of damage parts of RO/water purifier system and supply line like multiport valve, Dosing Pump, Foot Valve, Brass NRV, Brass NRV, UPVC Valve, UPVC MABT, UPVC TEE, UPVC MTA, UPVC SOCKET, UPVC MTA, UPVC UNION, UPVC MABT, UPVC TEE, UPVC ELBOW, UPVC VALVE, UPVC VALVE, UPVC VALVE, MS PLUG, TEFLON TAPE, SOLVENT, GI Sumo Nipple, GI Nipple, Pump Flange, Reduser, PVC Tank, SS Pipe (SS 304), End cap etc.
- (v) Nothing extra shall be paid to the contractor for above mentioned repair work.
3. Spares and Consumables are under Contractor's Scope.
4. **Taxes & Duties:** - Unless otherwise specified, the Quotationer shall pay such taxes and duties, fees and other impositions as may be levied under the applicable law. All payments to both resident and non-resident Quotationer etc. will be subject to deduction of tax at source in accordance with the provisions of India Income Tax Act and any other applicable law.
5. Successful Quotationer will send his representative on monthly basis at all station for maintenance of Water Filter Unit.
6. On stuck down of RO water supply besides the monthly maintenance, Employer shall call the Contractor for maintenance and will not pay any extra charge to contractor in any emergency. If Contractor representative would enable to attend the site within 2 days of stuck down of water supply, necessary service charges may be taken from Contractor on behalf of expenses incurred by Employer through other Contractor.

7. **Payment Terms: -**
- (i) **For AMC:** -Payment will be made on half yearly basis (first after 03 months from date of commencement and second after completion of maintenance at all 09 nos. of stations & after submission of invoice).
- (ii) **For MS Vessel, Activated Carbon and Membrane-** Payment will be made on as per actual basis and after submission of invoice.
8. **Completion period:** -The time allowed to complete the work is 01 year.
9. No variation in rates due to escalation/reduction due to change in price index shall be entertained.
10. Being Urgent nature of work, Quotationer shall adhere to complete the work within accepted completion period.
11. Rate quoted in the schedule of items shall be valid for a variation of the quantity upto maximum of (+/-) 50 % of contract value provided the value of contract including the variation amount is still within the powers of acceptance.
12. The scope of work as shown in schedule is tentative and may vary as per requirement of DFCCIL and may be utilized in nearby section under CGM/Jaipur unit, for which no compensation/transportation etc. may be entertained on this account.
13. DFCCIL reserve its power to terminate the quotation at any time, if considered reasonable in the interest of project and Quotationer shall have no right for compensation on this account.
14. Contractor shall be fully responsible for any error, difficulty in execution/damage incurred owing the things overlooked by him. However, the several documents forming the contract are to be taken as mutually explanatory of one another.
15. Contractor shall be fully responsible for safety of workmen during execution of work. In case of any mishap or unsafe working, DFCCIL will not be responsible, contractor will be solely liable for that.
16. In the case of discrepancy between schedules of quantities, the specifications and special condition of preference shall be given to description in the schedule of quantities. If there are varying or conflicting provisions made in any one document forming part of the contract, the accepting authority or the Employer shall be the deciding authority with regard to the intention of the document. Any error in decision, quantity or rate in schedule of quantities or any omission there from shall not vitiate the quotation or release the contractor from the execution of the whole or any part of the work comprised therein according to drawing and specification or from any of his obligations under the contract.
