1.0 GENERAL

- 1.1 This is a supply contract like all other supply contracts awarded by DFCCIL. Award of the Contract does not confer any right to any of the individuals involved in this contract either directly or indirectly for a perpetual employment in DFCCIL in any capacity. The agency / service provider / Contractor/Supplier shall be entirely responsible for the employment of its labour and shall be liable for observance of all statutory provisions. No claim of employment by the manpower engaged on the DFCCIL on whatsoever ground shall be entertained.
- 1.2 This contract is of temporary nature. DFCCIL shall have discretion to change the scope of work of contract as per the requirement.

2.0 Validity

- 2.1 The Contractor/Supplier shall to ensure the proper supply of items as per requirement of contract.
- 2.2 The contract shall be valid for a period of 90 days from the date of opening of Quotation unless specifically extended in writing by the DFCCIL Administration on written request of the Contractor/Supplier.
- 2.3 The time of extension may be considered if the delay is not attributable to the Contractor/Supplier.
- 2.4 DFCCIL Administration reserves the right to terminate the contract by giving 7 days' notice in case DFCCIL Administration desires to have its own arrangements.
- 2.5 DFCCIL Administration also reserves the right of termination of the contract with immediate effect at any stage of time. This will apply when the agency fails to abide by / comply with the special terms and condition(s) and / or the agency has not been able to follow or comply the laws of statutory provisions of Central / State Government in force or has / have breached any contract agreement condition.

3.0 Liability against risks / claims:



- 3.3 Contractor/Supplier will be responsible for compliance of all statutory laws in force at Contractor/Supplier own cost.
- 3.4 Quoted rates are inclusive of all Taxes, royalties, transportation etc. (Including GST). No claim whatsoever of any nature shall be entertained.
- 4.0 Rates
- 4.1 The rates quoted and accepted by DFCCIL shall be firm and final during the currency of contract.
- 4.2 All statutory taxes (Including GST) and liabilities levied / livable by the Central & State Government or any other governing authority / agency / from time to time shall be borne by the Contractor/Supplier and the rate shall be inclusive of all such liabilities.
- 4.3 All statutory deductions shall be made from bills as applicable as per DFCCIL/Govt. norms on such works.

5.0 SPECIAL CONDITION

- 5.1 Payment shall be made after receipt of material at destination.
- 5.2 Specifications - Rain Coat confirming to IS: 4761 of assorted sizes in orange color (two-piece type with coat and trouser) made of PVC coated 190 G Polyester Cloth, Double layer. Featuring high visibility retroreflective tape of Brand 3M Scotchlite of size 4.5 m in length and 50 mm in width. High visibility retro-reflective tape to be fixed on the Rain coat shall be discussed with buyer (Front and back of jacket and trouser). Adjustable hood with tying cord & lock and transparent face shield. adjustable bottom of the jacket by pulling type cord with locking system, zipper on the jacket with a cover of snap fastener locking system. Two hanging/patched cross pockets of size 15cm x 15cm with overlapped cover, Fullround covered elastic over the wrist. All joints tapped from inside with heat seal, Trouser adjustable with elastic and bottom can be adjusted with locking cord. - The supplier will discuss the design of the raincoat and the logo to be fixed on the 5.3 jacket with the buyer. No extra payment will be made to the supplier for this purpose.
 - The supplier will replace any raincoats with defects, such as incorrect size, 5.4 symmetry, color composition, other design defects, torn, poor stitching, etc., up to one month from the date of supply, at no cost.

- 5.5 Transportation/Delivery: Amount quoted shall be inclusive of transportation of the items/equipment's. The Raincoats shall be supplied at DFCC Station-New Rewari, Nearby- Thothwal village, District- Rewari, Haryana, 123401.
- 5.6 Completion period: 15 days from issuance of LOA.
- 5.7 Rate quoted in the schedule of items shall be valid for a variation of the quantity up to maximum of (+/-) 100% of contract value provided the value of contract including the variation amount is still within the power of acceptance.
- 5.8 Validity of Rates: Rates quoted should be valid for 90 days from the date of opening of quotation.
- 5.9 The Quotationer must submit their duly filled quotation and sign each page of Annexure-A, B & C and a token of acceptance of the term & conditions. No changes shall be allowed after submission of offer/quotation.
- 5.10 Payment will be made through RTGS, for which agency will have to submit required bank details. GST Invoice to be raised in the name of Dedicated Freight Corridor Corporation of India Limited with GST number 08AACCD4768M1Z5.
- 5.11 Agency has to submit copy of PAN & GST No. to DFCCIL.
- 5.12 It is advised to strictly adhere to format & Special Conditions attached herewith.

6.0 RATES TO BE ALL INCLUSIVE:

All statutory taxes (Including GST) and liabilities levied / livable by the Central & State Government or any other governing authority / agency / from time to time shall be borne by the Contractor and the rate shall be inclusive of all such liabilities. Total amount quoted shall be inclusive of transportation, All taxes/toll/Royalty, statuary duties, to be borne by Contractor only. No claim on this account shall be payable.

7.0 PERIOD OF COMPLETION:

The entire work is required to be completed in all respects within 15 days from the date of issue of the acceptance letter. Time is the essence of contract. The Contractor/Supplier shall be required to maintain steady and regular progress to the satisfaction of the Engineer to ensure that the work will be completed in all respects within the stipulated time.
