**Scope of Work: -** Consultancy work for preparation of RUBs/MIBs GAD of structural drawings for proposed connecting line from New Rewari to IR Kumbhawas DFCCIL line.

### I. Completion Period

The work will be completed within 60 days from the date of issue of the acceptance letter.

### II. Other Terms and Conditions

1. This is a works contract like all other works contracts awarded by DFCCIL. Award of the Contract does not confer any right to any of the individuals involved in this contract either directly or indirectly for a perpetual employment in DFCCIL in any capacity. The agency/ service provider/contractor shall be entirely responsible for the employment of its labour and shall be liable for observance of all statutory provisions. No claim of employment by the manpower engaged on the DFCCIL on whatsoever ground shall be entertained.
2. The work will be executed under supervision of Dy.PM/Works/JP or his representative.
3. The Contractor after issue of the acceptance letter shall inform the Dy.PM/Works/JP prior to start any execution work at the location.
4. All the materials and workmanship used in this work shall be of good quality and appropriate class in every respect and is expected to give trouble free service.
5. The Contractor will ensure to take all safety measures during the execution of the work.
6. Presence of an authorized DFCCIL's representative while execution work shall be ensured.
7. The work includes site survey at location of RUBs, MIBs, ERS, Ponds & other locations where land boundary is limited & retaining wall is required to retain embankment.
8. The Bridge proper having skew will have to be designed as per DFC standard of loading i.e 32.5T loading and provision as per IRS codes and as directed by Engineer.
9. Design of the return/retaining walls will have to be done on need basis.
10. The approval of design will be done by DFCCIL.
11. Modification if required during execution of work shall have to be done by consultant without extra cost.
12. The liasioning for approval of GAD from other authority shall be done by DFCCIL. However, the correction if required as per the observation of the authorities shall have to be done by consultant without extra cost.
13. The lodging, boarding or transportation of consultant representative to site for data collection shall be borne by consultant and DFCCIL shall not pay anything extra on this account.
14. The consultant shall give the final print of GAD/Structural drawing on tracing papers in addition, the final drawings and Design shall have to be submitted in soft copy in Auto CAD and pdf also.
15. The Contractor shall fill the 'Rate quoted Percentage Above/ Below the Total Estimated Amount' and 'Total Quoted Amount' in the **Schedule of Work**.
16. No Counter conditions will be accepted to any of the clauses contained in the quotation document.
17. DFCCIL's decision regarding acceptability of Technical Suitability of the offer shall be final.



And also reserves the right to delete items if not required and subsequent cost against those items will be deducted from contract value.
22. DFCCIL reserves the right to split / delete certain items of the tender without assigning any reason.
23. No T&P items will be supplied by this office for the said work.

### III Payment conditions

1. Itemised payment will be made for supply and execution items as per rates given in the Schedule of Works.
2. Wherever the Central/State makes it obligatory for the DFCCIL to deduct any amount towards GST or other taxes same will be deducted in addition to the income tax remitted to concerned authority.
