**Sub: -** Cleaning of DFC side drain at Km 1068/500 to Km 1069/820 between New Kishangarh and New Sakhun stations in CGM/Jaipur section.

**1.0 GENERAL**

- 1.1 This is a works contract like all other works contracts awarded by DFCCIL. Award of the Contract does not confer any right to any of the individuals involved in this contract either directly or indirectly for a perpetual employment in DFCCIL in any capacity. The agency / service provider / Contractor/Supplier shall be entirely responsible for the employment of its labour and shall be liable for observance of all statutory provisions. No claim of employment by the manpower engaged on the DFCCIL on whatsoever ground shall be entertained.
- 1.2 This contract is of temporary nature. DFCCIL shall have discretion to change the scope of work of contract as per the requirement.

**2.0 Validity**

- 2.1 The Contractor/Supplier shall to ensure the proper supply of items as per requirement of contract.
- 2.2 The contract shall be valid for a period of 90 days from the date of opening of Quotation unless specifically extended in writing by the DFCCIL Administration on written request of the Contractor/Supplier.
- 2.3 The time of extension may be considered if the delay is not attributable to the Contractor/Supplier.
- 2.4 DFCCIL Administration reserves the right to terminate the contract by giving 7 days' notice in case DFCCIL Administration desires to have its own arrangements.
- 2.5 DFCCIL Administration also reserves the right of termination of the contract with immediate effect at any stage of time. This will apply when the agency fails to abide by / comply with the special terms and condition(s) and / or the agency has not been able to follow or comply the laws of statutory provisions of Central / State Government in force or has / have breached any contract agreement condition.

**3.0 Liability against risks / claims:**

- 3.1 DFCCIL Administration shall not be responsible for any injury or loss of life or sickness of the workmen or of any individual involved in the contract (deployed by the agency / service provider / Contractor/Supplier) during the course of their duties or out of their duty hours. Any statutory liabilities which may arise shall be on the agency / Contractor/Suppliers (s) / service provider's account

- 3.2 The agency / service provider / Contractor/Supplier (s) shall be solely responsible for the compliance of statutory regulations applicable to Contractor/Supplier labour as also other Central and State Government Statutory regulations associated with works such as provision of Minimum Wages Act, 1984, the Work Men Compensation Act, 1923 etc. No liability whatsoever shall attach to the DFCCIL on account of or any failure on the part of the agency / service provider / Contractor/Supplier (s) to observe these regulations.
- 3.3 Contractor/Supplier will be responsible for compliance of all statutory laws in force at Contractor/Supplier own cost.
- 3.4 Quoted rates are inclusive of all Taxes, royalties, transportation etc. (Including GST). No claim whatsoever of any nature shall be entertained.

#### **4.0 Rates**

- 4.1 The rates quoted and accepted by DFCCIL shall be firm and final during the currency of contract.
- 4.2 All statutory taxes (Including GST) and liabilities levied / livable by the Central & State Government or any other governing authority / agency / from time to time shall be borne by the Contractor/Supplier and the rate shall be inclusive of all such liabilities.
- 4.3 All statutory deductions shall be made from bills as applicable as per DFCCIL/Govt. norms on such works.

#### **5.0 SPECIAL CONDITION:**

- 5.1 On Account Payments not prejudicial to final settlement: - “On-Account” payments made to the ‘Contractor shall be without prejudice to the final making up of the accounts (except where measurements are specifically noted in the Measurement Book as “Final Measurements” and as such have been signed by the Contractor and Engineer’s/Engineer’s Representative) and shall in no respect be considered or used as evidence of any facts stated in or to be inferred from such accounts nor of any particular quantity of work having been executed nor of the manner of its execution being satisfactory.
- 5.2 Measurement of works by DFCCIL:- The Contractor shall be paid for the works at the rates in the accepted schedule of rates and for extra works at rates determined under Clause 39 of GCC on the measurements taken by the Engineer or the Engineer’s representative in accordance with the rules prescribed for the purpose by the DFCCIL. The quantities for items the unit of which in the accepted schedule of rates is 100 or 1000 shall be calculated to the nearest whole number, any; fraction below half being dropped and half and above being taken as one; for items the unit of which in the accepted schedule of rates is single, the quantities shall be calculated to two places of decimals. Such measurements will be taken of the work in progress from time to time and at such intervals as in the opinion of the Engineer shall be proper having regard to the progress of works. The date and time on which “on account” or final measurements are to be made shall be communicated to the Contractor who shall be present at the site and shall sign the results of the measurements (which shall also be signed by the Engineer or the Engineer’s representative) recorded in the official measurements book as an acknowledgement of his acceptance of the accuracy of the measures.

- 5.3 Completion period: - One year from issuance of LOA.
- 5.4 For the payment of all items in Schedule A and Schedule B, the net quantity payable shall be determined after an 8% deduction from the quantity actually measured to account for voids and looseness.
- 5.5 The work is to be executed in the vicinity of the DFC track. The contractor shall be solely responsible for the safety of the manpower, machinery, and trains. Any loss incurred due to carelessness on the part of the contractor shall be borne entirely by the contractor. Rate quoted in the schedule of items shall be valid for a variation of the quantity up to maximum of (+/-) 50% of contract value provided the value of contract including the variation amount is still within the power of acceptance.
- 5.6 Validity of Rates: - Rates quoted should be valid for 90 days from the date of opening of quotation.
- 5.7 The quotationer must submit their duly filled quotation and sign each page of Annexures A, B, and C as a token of acceptance of the terms and conditions. No changes shall be allowed after the submission of the offer/quotation.
- 5.8 Payment will be made through RTGS, for which agency will have to submit required bank details. GST Invoice to be raised in the name of Dedicated Freight Corridor Corporation of India Limited with GST number 08AACCD4768M1Z5.
- 5.9 Agency must submit copy of PAN & GST No. to DFCCIL.
- 5.10 It is advised to strictly adhere to format & Special Conditions attached herewith.

**6.0 RATES TO BE ALL INCLUSIVE:**

All statutory taxes (Including GST) and liabilities levied / livable by the Central & State Government or any other governing authority / agency / from time to time shall be borne by the Contractor and the rate shall be inclusive of all such liabilities. Total amount quoted shall be inclusive of transportation, All taxes/toll/Royalty, statutory duties, to be borne by Contractor only. No claim on this account shall be payable.

**7.0 PERIOD OF COMPLETION:**

The entire work is required to be completed in all respects within one year from the date of issue of the acceptance letter. Time is the essence of contract. The Contractor/Supplier shall be required to maintain steady and regular progress to the satisfaction of the Engineer to ensure that the work will be completed in all respects within the stipulated time.

**8.0 Quantum of work and materials:**

The indicative schedule of quantities of various items of works is included in Annexure -B of the tender documents.
