Government of India has received financing from the World Bank vide Loan No. IN 8066 and intends to apply part of the proceeds for Engagement of Consultant for a study on the Special Railway Establishment for Strategic Technology & Holistic Advancement (SRESTHA) in Indian Railways.

The consulting services (“the Services”) include the study to recommend the responsibilities, scope of activities, structure, staff, financial model and assets of SRESTHA, based on international models, adapted to the Indian situation and prepare a plan for establishing it.

The Dedicated Freight Corridor Corporation of India Ltd. (DFCCIL) now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing shall be done based on experience of the company in similar assignments covering components of assignment during last seven years, company profile, available permanent staff for similar assignment, turnover of the company in last five financial years, and any other relevant information provided by the applicant to prove their ability to perform the services in this assignment. Similar assignments required and information to be provided by the applicant are included as Annexure. .

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank’s *Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers* of January 2011, revised July 2014 (“Consultant Guidelines”), setting forth the World Bank’s policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub consultancy to enhance their qualifications.

A Consultant will be selected in accordance with the QCBS method set out in the Consultant Guidelines.

5. Details of Staff available with the company on its permanent roll for similar assignments (*similar assignments explained in foot note 1*) (There is no need to provide CV of staff at this stage)
6. Any other information applicant may like to indicate that they are qualified to perform the services.

¹ Similar assignments mean the consultancy assignment pertaining to setting up of a technical research institute and/or improving the existing functioning or facilities for technical research in Infrastructure sectors. Preference shall be given to transport sector assignments and highest preference for railways sector assignments.

² Only those assignments should be included, which have been carried out by the applicant. The assignments carried out by parents/sister companies should not be included.

³ Components of assignment should be indicated as :

- (a) Setting up of technical research institute.
- (b) Improving the existing functioning or facilities for technical research in Infrastructure sectors.
