In the S.N. 1, Information was sought about the Duties of E2 Level Engg. official (Designation Track) posted at IMD Level as per para 201(ii) of DFC Railroad manual2024. But in the reply of RTI, information was given about the duties of IMSD (In ChargeEngg) as per para 226 to 236 of DFC Railroad manual. In DFC Railroad manual, no specific duties is given for this E2 level post at IMD level. So Please clarify that if E2 level official is posted at IMD, not at IMSD level, than what will be his duties for his post at IMD? 2.In S.N.2, Information was sought about the length of section jurisdiction of IMSD (In Charge) and IMSD (Sectional) posted at IMSD Level as per para 201(i) of DFC Railroad manual. As per para 201(i) of DFC Railroad manual, at IMSD level, one number of post for E2 level as IMSD Incharge and one number of post for E1 level as IMSD Sectional is defined. But in DFCCIL, generally an IMSD incharge is having jurisdiction (length of one IMSD jurisdiction approx. 60 to 70 Kms) of 2 DFCCI Operating stations. (section jurisdiction of an IMSD Incharge (approx. 60 to 70 kms) or there will be two or more official as IMSD Sectional (E1 level) will work for entire jurisdiction of an IMSD Incharge (approx. 60 to 70 kms) or there will be two or more officials will work as IMSD sectional for different stations under one IMSDIncharge (E2 level) ? 3.In S.N.3, Information was sought about the length of section jurisdiction of IMSD (In Charge) and IMSD (Sectional) posted at IMSD Level as per para 201(i) of DFC Railroad manual. As per para 201(i) of DFC Railroad manual, 1 post for IMSD In Charge (E2 level) and 1 post for IMSDSectional (E1 level) is defines at IMSD sectional under one IMSDIncharge 4. In S.N.4, Information was sought about duties, roles and responsibilities for 3 nos of posts E0 level (as Pway Spl,Works, Misc) at IMSD level as per para 201(i) of DFC R
