3. On the basis of JMS and Para 104, the award was declared by Competent Authority and payment to PAP was made.
4. On request of PAP, DILR has again surveyed the area and submitted their report to Competent Authority vide which some area increase in DILR report from their previous report.
5. As soon as Competent Authority has conveyed DFCC regarding increase in area of the said survey no., DFCC has submitted the 20A again for the said survey no. & processed for gazette publication. Copy of schedule along with letter of SLAO/PNU is attached.
6. After completion of due process of land acquisition, the payment to the PAP shall be made.






