CO/HR received a request from Shri Abhisek Kumar Maury (EC-104295), JPM/Civil/BRC, for a No Objection Certificate (NOC) for external employment as Deputy Manager in Engineer India Limited on 20/09/2024, duly forwarded by BRC Unit. This request was recorded and subsequently forwarded to the Confidential Cell/CO on 23/09/2024, along with a reminder dated 08/10/2024 for obtaining the D&amp;AR status.</p> <p>II. The Confidential Cell/CO provided the D&amp;AR status on 29.10.2024, indicating that Shri Maury has not submitted his IPR for the year 2023.</p> <p>III. Regarding the vigilance clearance status, the Vigilance department advised that the online portal for seeking and providing vigilance status has been implemented. Therefore, it is recommended to obtain the vigilance status through the online mode only, as directed by the Competent Authority.</p> <p>IV. This information was communicated to the BRC Unit on 29/10/2024, with a request to inform Shri Maury to submit his NOC request via the IT Connect portal, clearly indicating the D&amp;AR status.</p> <p>V. As of now, CO/HR has not received any request from the employee for the issuance of NOC for external employment through the specified portal.</p> <p>VI. This concludes the current status of the matter.</p>
