**Sub:- Development of Traction Distribution Management System (TDMS) for DFCCIL.**


Ref: This office letter of even no. dated 05/02/2024.

DFCCIL has also signed an MoU with CRIS for development of TDMS software module for 2x25 kV OHE & PSI system.
