<b>Text of Appeal</b>		<p>To, The First Appellate Authority, Dedicated Freight Corridor Corporation of India Limited (DFCCIL), Mughalsarai. Subject: First Appeal under RTI Act, 2005 – Seeking Clarification Regarding Response to RTI Application Reference: RTI Application dated 28/10/2024 Reply received from the Public Information Officer dated 27/11/2024 Dear Sir/Madam, I am writing to file this First Appeal under Section 19(1) of the RTI Act, 2005, as I am dissatisfied with the response received to my RTI application. In my RTI application, I sought specific information regarding the eligibility and disbursement of the Diwali Bonus for UP Purva Sainik Kalyan Nigam Ltd employees and DGR Keyman under DFCCIL. However, the reply received is vague and does not address all my queries comprehensively. The issues with the reply are as follows: 1. Lack of Specificity Regarding Eligibility Criteria: My first query sought clarity on whether UP Purva Sainik Kalyan Nigam Ltd employees are eligible for the Diwali Bonus. The response does not explicitly clarify their eligibility status or the rationale behind it. 2. Responsibility for Bonus Disbursement: While the reply states that payment or a gift card was provided as per Circular No. 40/2024, it does not clearly specify who is responsible for disbursing the bonus to these employees (UP Purva Sainik Kalyan Nigam Ltd or DFCCIL). 3. Details of Complaint Mechanism and Proof of Payment: My queries regarding the complaint mechanism for non-receipt of the bonus and proof of disbursement (e.g., payment records, list of beneficiaries) were not adequately addressed in the reply. Relief Sought: I request that the First Appellate Authority kindly direct the Public Information Officer to: - Provide explicit answers to each of the queries raised in my RTI application. - Clarify the eligibility status and responsibility for Diwali Bonus disbursement. - Share the complaint mechanism and proof of disbursement, if applicable. I trust that the First Appellate Authority will ensure that I receive complete and specific information within the stipulated time frame as per the RTI Act. Enclosures: 1.
