Also, CPIO not provided the Information asked in Point No. C stating "As the same involves personal information the point is rejected under Section 89j) of RTI Act 2005." Whereas, the Requested information asked the Correspondences from World Bank to DFCCIL and it's an Official Record and DFCCIL official records does not falls under personal information. I have not asked the Approval letter of DFCCIL to PMC which may falls under Personal Information as a private party involved in this communication. And, CPIO does not mention the Type of Approval in the Point No. D as for this incidents shared in the RTI, possibility of 02 kind of Approval – 1. DFCCIL Departmental Approval only, 2. DFCCIL Approval after approval from World Bank. Complete 1st Appeal enclosed.
