- 1. In this regard, we submit that the Said Documents, as sought by Mr. A.D. Bhandari, are not required to be furnished as this being our personal information and the disclosure of which has no relationship to any public activity or interest.
- 2. With respect to the request of providing copies of Said Documents and other details, we state that the disclosure of the same might harm our competitive position and can cause unwarranted invasion of the privacy. We apprehend that the said information, if divulged might fall in the wrong hands and may be used by competitors and rival organisations which shall be prejudicial to our interests. It is also submitted that the said information is absolutely confidential and privileged one and hence such permission should not be granted to Mr. A.D. Bhandari.
- 3. In reference to our above referred submissions we would like to draw your kind attention to the provisions of Sec.8(1) (d), (e) & (j) of the RTI Act which reads as under :-
 - "..8.(1) Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen,—
 - information, disclosure of which would prejudicially affect the sovereignty and integrity of India, the security, strategic, scientific or economic interests of the State, relation with foreign State or lead to incitement of an offence;

j. information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information:"

We further submit that our case is squarely covered by the aforesaid provisions of Section 8(1) of the RTI Act which clearly states that the information, which is of commercial confidence, trade secrets, intellectual property or harm of the competitive position should not be disclosed.

- 4. It appears that Mr. A.D. Bhandari has sought Said Documents only in the personal interest with oblique motive and no large public interest warrants the disclosure of such information. Your attention is invited to the recent decisions of the Hon'ble High Courts of the country and also of the Hon'ble Supreme Court wherein it is held that no information should be supplied under the RTI Act if such disclosure of such information is likely to be misused for personal interest and for rowing inquiry. Disclosure of information cannot be permitted to lead into multiplicity of unwarranted proceedings at the instant of persons having vested interests.
- 5. In view of above and also Section 11 of the RTI Act, we hereby inform that we have a strong objection in providing any information to Mr. A.D. Bhandari and we request your good office not to divulge any information to Mr. A.D. Bhandari as sought by him and reject his application.
- 6. Further, we would like to request not to furnish such information without our prior concurrence, even in future if your good authority is in receipt of such request/application by Mr. A.D. Bhandari or any other applicant.
