





Sub: Duty Roster of Operating staff for New Khurja – New Bhaupur & New Rewari-Madar sections

New Khurja – New Bhaupur sections of EDFC and & New Rewari- Madar sections of WDFC have been opened for commercial run of Goods trains from 29 December-2020 and 07 January-2021 respectively.

As per Clause-7 of Railway Servants (Hours of Work and Period Of Rest) Rules 2005," All employments of Railway servants except those exclude from the purview of the Hours of Employment Regulations are assumed to be 'Continuous', thereafter, on the basis of factual job analysis, the employment may be classified either as "Intensive" or "Essentially intermittent", as the case may be".

Keeping in view above clause-7 and quantum of workloads, Operating staff for New Khurja – New Bhaupur & New Rewari- Madar sections (Executive & MTS working at stations as well as level crossing gates including RG) will follow 'Continuous Roster' as under:-

- (iii) 22.00 PM to 06.00 AM
