
Sub : Handing over of land and other details of Sonnagar-Dankuni section

1) As you are aware, Sonnagar-Andal section (375 km) of Sonnagar-Dankuni Project (538 km) of Eastern Dedicated Freight Corridor has been sanctioned by Railway Board as Multi-Tracking work and is to be executed by ECR and ER.

2) It is to mention that DPR for this work was prepared by DFCC and land acquisition, alignment plans, ESPs, GADs, planning and execution of ROBs, land acquisition for ROBs/RUBs, construction of staff quarters and other related works between Sonnagar to Dankuni stations were being carried out by DFCC for last few years. A sizeable quantity of land acquisition has already been carried out. This work was entrusted to GM/Co/DFCC/Kolkata. It is to further advise that utility shifting for this work was being carried out by ECR in Sonnagar Gomoh section and the work of utility shifting in ER jurisdiction is yet to be taken in hand. Several project matters related to other agencies such as State Government of Bihar, Jharkhand and Bengal, Forest Department, NHAI, WII, Irrigation authorities etc were also being handled by DFCC through GM/Co/Kolkata.

3) It is imperative that further work of land acquisition, utility shifting, staff quarters and project execution is now to be carried out by ECR and ER respectively and therefore existing details and records of the project should be taken over from DFCC at the earliest. Necessary instructions have been issued to GM/Co/Kolkata to handover the details and records to ECR and ER expeditiously and not to incur any new financial commitment.

4) It is, therefore, requested that one suitable SAG officer both from ECR and ER may be deputed to take over the records and other details from GM/Co/Kolkata at the earliest and this process may be completed by the end of Sept, 2023. Further work of planning, land acquisition, construction of ROBs/RUBs, staff quarters and liaising with other agencies in addition to core project execution may also be suitably taken up at your end.
