

1	What is the minimum qualification for the post of Technician?	No specific qualification for technician is mentioned in contract. However, personnel desired to be deputed for the work including supervisors have to undergo a scrutinizing test conducted by GM/EL/DFCCIL or his authorized representative.
2	What is the minimum monthly salary fixed by DFCCIL for the technician and helpers employed on contract basis with Vindhya company?	<ol style="list-style-type: none"> As per the current contract, salary of skilled person for maintenance of General Power Supply (E&M) items for DFCCIL stations, IMD, IMSD, staff quarters, RHs and CGM office etc. is Rs. 953.36+7.70% per day. As per the current contract, salary of unskilled person for maintenance of different E&M activities is Rs. 677.64+7.70% per day.
3	How much PF and ESIC are deducted for the technicians and helpers employed on contract basis?	The complete details of PF and ESIC deduction have been maintained by the contractor M/s Vindhya RB JV-Bhopal. However, the payment records are available at CGM/Ambala unit. It can be seen on any working day between 09:30-17:30 hrs. for further information.
