DFCC001081 & Roll No. 17180900031) vide Advt. No. 02/2020. I was shortlisted for the post mentioned above as the result declared dated 18.01.2021 (copy attached) and received a call letter (Copy attached) for document verification & in such document verification I got rejected for the same post.</p> <p>I request you to refer following details w.r.t. above</p>	
1	<p>I was rejected stating my ineligibility for the post as I have not pursued B.Com (Graduation) for 03 years FULL TIME. As per my contention, it is written only 3 years Full time & not 3 years Full time REGULAR in advertisement 02/2020. Please elaborate meaning of FULL TIME, since it was not mentioned in Advertisement 02/2020.</p>	<p>RTI replies are given as per the record available beyond that nothing can be added, interpreted or clarified. Since no elaboration is available on record, nothing can be provided.</p>
2	<p>I have pursued my graduation from School of Open Learning, Delhi University (hereinafter referred as SOL (DU), which I have clearly mentioned in Application form(copy attached). The Document Examination Committee answered that SOL(DU) would not be considered as full time because as per their opinion SOL(DU) does not conduct classes on a regular basis or conducts classes only on weekends which makes SOL(DU) a Non Full Time Institute. But SOL(DU) conducts classes on weekends as per their curriculum and I have studied the whole course & only then I was able to secure my marks in SOL(DU) B Com Graduation. Basically, they challenged regularity of SOL(D) classes degree but,</p> <p>-As per latest SOL(DU) Prospectus (Copy attached - refer page 34) all courses provided by SOL(DU) are recognized by Distance Education Bureau (DEB-UGC) &</p> <p>-As per DEB FAQ question no. 10 read with notification (copy of both FAQs & notification attached) " The Degrees/Diplomas/Certificates awarded for programmes conducted by the ODL institutions (SOL), recognized by the erstwhile DEC/UGC (copy attached), in conformity with UGC Notification on specification of Degree should be</p>	<p>No information is sought for but the grievance has been described here which is not covered under Section 2(f) of RTI Act 2005.</p>

	<p>treated as equivalent to the corresponding awards of the Degree/Diploma/Certificate of the traditional Universities / Institutions in the country.”</p> <p>-As per above references of DEB-UGC and as per my contention, degree/certificates provided by SOL(DU) should be treated as equivalent as regular degree/certificates</p>	
3	<p>I have provided clarification regarding the phrase REGULARITY AND FULL TIME in the attached file (Refer (b) point - Details attached also) and even on such day. Therefore, I now seek an explanation on what grounds I have been disqualified, also the document examiner Mr. Amit Kumar (Deputy General Manager-HR) made a clear oral statement to me stating that they have a letter from DEB-UGC, and according to which, it is in hands of the employer whether to select a candidate based on Degree of SOL (DU) or not, please provide such letter also.</p>	<p>Information sought is not covered under Section 2 (f) of RTI Act 2005. Comments cannot be given for any officer's statement, which is not on record.</p>
4	<p>I request you to please refer attachment, provide required document & answer to question mentioned in attached file. Further, kindly answer following questions with respect to the above stated matter: If it was a precondition that SOL(DU) graduates are ineligible for this post, then even after feeding / mentioning School of Open Learning as College name in the application form (copy attached):</p>	<p>Information sought is not covered under Section 2(f) of RTI Act 2005. 4(a)	<p>Why did DFCCIL not rejected me at the initial stage as my qualification were not the same as desired by them?</p>
