I want to know the following details of Open Market recruitment for the post of Junior Executive (Signal & Telecommunications) against advertisement no 04/2021.		
1	Kindly provide the Combined merit list of the above mentioned post where the category and the marks obtained by each of the candidates should be mentioned. As I am a candidate of this recruitment, CPIO Sir shall note that the denial of merit list under Section 8(1)(j) of RTI Act was not appropriate as merit list of recruitments held for public posts should ordinarily be available in public domain in the interest of transparency and probity.	Combined merit list contains the name, community, gender and date of birth besides marks/rank obtained by all candidates who appeared in CBT which is third party information. Thus, information sought is exempted from disclosure under section 8 (1)(j) of RTI Act 2005 as it relates to personal information and would cause unwanted invasion of the privacy of the individuals. Moreover, recruitment process for the post of Jr. Executive/S&T is still underway.
2	In the above said merit list it was mentioned that Four PwBD posts are carried forward. After carried forward what was the category wise vacancies for which merit list had been prepared.	
3	In the above-mentioned merit list of 143 candidates please mention how many UR, OBC, SC, ST & EWS candidates were shortlisted separately, please also mention how many UR Ex-Servicemen, OBC Ex-Servicemen, SC Ex-Servicemen, ST Ex-Servicemen & EWS Ex Servicemen candidates were shortlisted separately and also how many UR PwBD, OBC PwBD, Sc PwBD, ST & EWS PwBD candidates were shortlisted separately.	
4	In the above mentioned 1st waiting list of 46 candidates please mention how many UR, OBC, SC, ST & EWS candidates were shortlisted separately, please also mention how many UR Ex Servicemen, OBC Ex-Servicemen, SC Ex-Servicemen, ST Ex how many UR PwBD, OBC PWBD, Sc PwBD, ST & EWS PWBD Servicemen & EWS Ex-Servicemen candidates were shortlisted and candidates were shortlisted separately	Recruitment process for the post of Jr. Executive/S&T is still underway. The information sought in the desired format has not yet been tabulated.

5	In the above mentioned 2nd waiting list of 17 candidates please mention how many UR, OBC, SC, ST & EWS candidates were shortlisted separately, please also mention how many UR Ex Servicemen, OBC Ex-Servicemen, SC Ex-Servicemen, ST Ex Servicemen & EWS Ex-Servicemen candidates were shortlisted and how many UR PwBD, OBC PwBD, Sc PwBD, ST & EWS PWBD candidates were shortlisted separately.	
6	After successfully completion of DV and Medical, 85 Nos of candidates have joined for training, so it is expected that the first waiting list should be of 58 candidates but in the 1st waiting list only 46 candidates had been shorlisted, kindly mention what will be done with the remaining 12 vacancies.
