Grievance under reference has been examined by the Mumbai/South unit of DFCCIL and itemized remarks on the complaint are tabulated below:-

S. No.	Description of the complaint	Reply
a.	It is observed that D/N - 77, 78/1, 78/2 have submitted forged documents and records for the compensation under the Dedicated Freight Corridor Corporation of India project at the site 79/20, 79/24, 75A/5A these all have been involved in the forgery activities in the project in terms of false and fake documents and records.	Your observation is forwarded to DRO i.e. Dy. Collector (Rehabilitation), Palghar who is the Competent Authority to finalize the eligibility of Project Affected Persons (PAPs) for Resettlement and Rehabilitation (R&R) benefits for further necessary action.
b.	Incomplete demolition of the structures of DN- 77 in spite of availing full compensation.	Affected structure within DFC Right of Way (RoW) has been demolished.
c.	Malpractices and corruption by the local authority of DFCCH and Dy. Collector Palghar (Rehabilitation).	Please come up with material and physical evidences against corruption and corrupt officials. We will take up with the anti-corruption agency if material evidence is given.
d.	I request the above mentioned authority to look into such malpractices and initiate enquiry against the local authority and stake holders involved in such malpractices.
