



The item wise information as sought by of Sri Sachindra Nath Bandyopadhyay, S/o Narendra Nath Bandyopadhyay, of Vill+Post+PS-Gurapr, Dist-Hooghly, West Bengal, PIN-712303 vide above subject and reference is furnished below:

1. *The Competent Authority under Railways Act, 1989 and Additional District Magistrate (Land Acquisition), Hooghly has handed over the possession of 0.06 Acres acquired land of plot no. 569 along with acquired areas of other plots in Balidaha mouza, J.L. No. 125, P.S:- Dhaniakhali on 29.12.2017. Thereafter, the acquired land was mutated in the name of Govt of India (Ministry of Railways) on 27.08.2018, on application to Block Land and Land Reforms officer, Dhaniakhali, Hooghly.*
2. *The Central Government in the Ministry of Railways had acquired land in Balidaha mouza, J.L. 125, P.S:- Dhaniakhali as per provision of Railways Act, 1989. The different notification issued as per provision of the Act are as below:*
 - a. *Notification u/s 20A vide S.O. 516(E) dated : 20.03.2012 was published in the Gazette of India vide no. 439, dated 20.03.2012.*
 - b. *Substance of notification as mentioned in (a) above was published in Local Newspaper i.e. 'The Statesman, Kolkata' on 10.05.2012 and 'Sambad Pratidin' on 12.05.2012.*
 - c. *Notification u/s 20E vide S.O 1021(E) dated 23.04.2013 was published in the Gazette of India vide no. 898 dated 23.04.2013.*
 - d. *Substance of notification as mentioned in (c) above was published in local newspaper i.e. 'The Statesman, Kolkata' on 25.07.2013 and 'Sambad Pratidin' on 25.07.2013.*
 - e. *Notification u/s 20F was published in local newspaper i.e. 'The Statesman, Kolkata on 20.06.2014 and 'Sambad Pratidin' on 20.06.2014.*
3. *Already replied in sl no. (1) and (2) above .*
4. *Compensation for acquisition of land in Balidaha mouza, J.L 125, PS; Dhaniakhali is being disbursed by the Competent Authority under Railways Act, 1989 and Additional District Magistrate (Land Acquisition), Hooghly. Applicant may be directed to contact the office of the Competent Authority under Railways Act, 1989 and Additional District Magistrate (Land Acquisition), Hooghly for further information.*
