IN FAVOUR OF Dedicated Freight Corridor Corporation of India Limited, a Government of
India (Ministry of Railways) Enterprise having its head office at 5th Floor, Supreme Court
Regd Metro Station Building Complex, New Delhi-110001, herein referred to as "DFCCIL"
(which expression shall include its successors and assigns) FOR A SUM
OF Rs. 200000/- (Rs.

Two lakhs) plus GST.

WHEREAS:

01. DFCCIL vide its letter no. HQ-HRRECT(OMRR)/1/2022-HK-RECT dated 10/08/2022 has given an Offer of Appointment to the employee herein stipulating the terms and conditions of employment. The employee has unconditionally accepted all the terms and conditions in the the Offer of Appointment on 21/08/2022.
02. The probationer/Employee is aware that the employer would be incurring substantial sums of money and incurring substantial costs, expenses, man hours in the process of selecting and appointing him/her as Probationer & training him/her thereafter.
03. This service agreement cum surety bond executed with the employer/DFCCIL by the probationer/employee along with a surety to the extent of Rs. 200000/- (Rs. Two lakhs) plus GST will be used for indemnifying the employer/DFCCIL against all such costs as mentioned above by reason of breach and/or non-compliance of any of the terms of this agreement by the probationer/employee
04. The said Offer of Appointment inter alia stipulates that the employee shall execute a Service Bond for a minimum period of three years from the date of joining the service and if the employee leaves DFCCIL for any reason whatsoever before completion of three years i.e. thirty-six months therefrom, he/she will have to make payment of Rs. 200000/- (Rs. Two lakhs) plus GST to DFCCIL.
05. THE SURETY has undertaken the liability as a surety and guaranteed due performance of the said Bond by the employee and payment of guarantee bond amount in case of default by the employee.

NOW THIS DEED WITNESSETH AND The Employee AND THE SURETY AGREE, UNDERTAKE AND BIND THEMSELVES AS UNDER:

01. That if the employee for any reasons whatsoever resigns, discontinues, or abandons the services or leaves the DFCCIL or remains absent un-authorized before expiry of three years from the date of joining the service the employee shall forthwith pay to the DFCCIL the said sum of 200000/- (Rs. Two lakhs) plus GST on demand without demur.
02. In case of default by the employee in due performance of the bond and payment of the said amount, the surety bind himself/herself to pay the said amount to the DFCCIL forthwith on demand without demur.
03. The liability of the employee and THE SURETY shall be joint and several.
