Supplementary draft award of left over 31 Fruit bearing trees in survey Nos 14,15 & 16 at Village Saphale of Taluka &, Dist. Palghar in F/o Shri Bandu Gopal Patil & others is received in this Office.

During the scrutiny of the said award it is noticed that the subject award has been declared for 31 Fruit bearing trees in Survey Nos 14, 15 & 16 jointly as per the Panchanama repared during treecutting. 100 % solatium has been included on the valuation of the trees included in the award. However land award for 0.0177 Ha land in Suvey No 14 was declared in first stage award dtd 19.09.2013. Moreover 100 % solatium has not been included in the Non fruit bearing trees draft award decaled recently by your office for 55 Non fruit bearing trees in Survey No 14 Part vide letter No भुसंपादन/कावि-१४०/२०१४ दिनके ०८/०४/२०१९.

Hence this office is of the openion that the Panchanama may be got reviewed for exact number of trees in Survey No 14 and the award may be corrected accordingly.
