As such information can not be picked out of the records to provide you. However, since you are interested in inspection of the records, you are welcome on working day during office hours but the date and time mutually acceptable to both. Kindly inform date and time of visit. |
| 2       | After inspecting these documents, if I require copies of any documents, please provide them upon payment of the prescribed fee as per the law.   |   |
| 3       | According to Section 2(j)(3), every citizen has the right to obtain a certified sample of the materials used in government work. Under this provision, I wish to obtain a certified sample of the materials used in the aforementioned work. The sample should be collected by the department in my presence from a location of my choice. It should be sealed and certified by the department, confirming that the sealed sample is an authentic representation of the material used in the work.
