Vide letter under ref-(v) above, this office is in receipt of letters from Sh. Mangli Ram S/o Late Shri Gordhan Singh R/o Village & P.O.-Kheri Kalan (Gidra Mohalla), Distt-Faridabad complaining regarding settlement of claim amount Rs.2,10,000/- against 70% loss of his two acres vegetables crop due to heavy dust flown by private heavy vehicles running on service road (Kaccha Rasta) i.e. in between DFCCIL Bridge No.166A-167 on daily basis.

In this matter, Noida Unit vide various letter under ref-(ii), (iii) & (vi) above, already wrote to PMC and L&T for an early resolution of the issue. PMC vide letter under ref-(vii) above, also forwarded the grievance to L&T for immediately resolution. However, despite of continuous correspondences in this regard, the matter has not been yet resolved and is still pending with L&T.

Now, vide letter under ref-(viii) above, the complainant again made a complain on CPGRAMS Grievance Portal regarding the issue. Accordingly, Corporate Office vide letter under ref-(viii) above, directed Noida Unit to resolve the grievance at the earliest.

The matter has been continuously highlighted by PAP to PMO and other related grievance forums. This office vide various letters dated 01-12-2020 & 16-02-2021 etc., wrote to PMC and L&T for early resolution of the issue.

Taking a serious note on the issue, L&T (as main contractor) should look into the matter immediately and ensure that the above issue shall be resolved in an amicable manner at the earliest. Accordingly, the action taken by L&T in this regard shall be updated to this office so that the same can be sent to Corporate Office/DFCCIL.
