

Please refer our letter at (4) above vide which your response was requested, which is still awaited. However, DFCCIL has again written to us regarding the above subject of Shri Prem Raj S/o Dharam Pal, Village Nacholi, District Faridabad.

As per complaint lodged on CPGRAM by him, details of which are shared in DFCC letter at (5) above, he has claimed that L&T Sub-Contractor Shri Pratap S/o Shri Udaybhan has not paid him remaining 3.00 lakhs for the soil excavated from his fields.

You may please look into the matter and resolve the issue within a week's time and report compliance under intimation to this office & DFCC latest by 27th Feb. 2021.
