Sub: Extension of re-employment tenure of Shri Rama Shanker Mishra re-employed as Dy.PM/HR/ALD (East).

Shri Rama Shanker Mishra, retired Dy Secy./PG/NCR/ALD joined DFCCIL as Dy.PM/HR/ALD (E) on re-employment basis on 13.03.2019 and his sanctioned re-employment tenure with DFCCIL was upto 12.03.2020. CPM/ALD (East) vide their letter dated 20.12.2019 placed at SN-36 has forwarded a proposal regarding extension of re-employment tenure of Shri Rama Shanker Mishra, Dy.PM/HR/ALD (East) for a further period of one year i.e. from 13.03.2020 to 12.03.2021.

- 2. In this regard, kind attention is invited to extract noings at PP-1 & PP-2. It may be seen that since issue of vacancy notice against the post of Sr. Executive/Jr. Manager/AM (HR) at DFCCIL/ALD (East) on deputation basis was under process, wherein it was decided that if we get regular employee at ALD (E), we will not extend the re-employment tenure of Shri Mishra.
- 3. Accordingly, the proposal for extension of re-employment tenure of Shri Mishra was not processed further. In the meantime, NOC for acceptance of Shri Deepak Gupta, CSWI/HQ/NCR, ALD for the post of APM/HR/ALD (East) on deputation basis vice Shri Rama Shanker Mishra was conveyed vide this office letter dated 06.02.2020 (SN-4) with a copy endorsed to CGM/ALD (East). Further, CGM/Allahabad (East) unit was advised that Shri Mishra may be relieved on completion of his sanctioned re-employment tenure i.e. 12.03.2020 vide e-mail dated 06.02.2020 (SN-5).
 - 4. Thereafter, further references for extension of re-employment tenure of Shri Mishra have also been received from time to time i.e. on 11.02.2020 (SN-6), 27.02.2020 (SN-7) and 09.03.2020 against which it has been reiterated that acceptance of Shri Deepak Gupta, CSWI/HQ/NCR, ALD for the post of APM/HR/ALD (East) has been given vide e-mail dated 12.03.2020 that the post of APM/HR/ALD (E) vice Shri Mishra has been filled up on regular basis on joining of Shri Deepak Gupta. Further, requirement of manpower in HR/ALD (E & W) if any, would be reviewed after April, 2020, however, further requirement if any, would be filled up on regular basis. Accordingly, again CGM/ALD (E) was requested that Shri Mishra may be relieved on completion of his sanctioned re-employment tenure i.e. 12.03.2020. Since, re-employment tenure of Shri Mishra has expired on 12.03.2020, necessary due settlement of Shri Mishra has been run on SAP w.c.f. 13.03.2020.
 - 5. Now, CGM/ALD (E) vide their letter dated 14.03.2020 (SN-10) has communicated that since there is no HR officer to look after the HR work of CGM/ALD (E & W) Units, therefore, Shri R S Mishra could not be relived. Further mentioned that Shri Deepak Gupta is an inspectorial staff, as such he will not be able to cater the need of entire HR work of ALD (E&W) Units.

- In view of the above, it has been proposed by CGM/ALD (E) that Shri Mishra presently working as Dy.PM/HR/ALD (E&W) may please be granted extension beyond 12.03.2020 i.e. from 13.03.2020 to 12.03.2021 as Consultant/APM/HR in ALD (West) unit for which a strong recommendation has already been submitted to Corporate Office for requisite extension of Shri Mishra.
- Sanctioned strength and on-roll position of HR department is placed at SN-11. Further, attention is invited to extract notings/orders (approved by MD) placed at SN-12 & 12/1 wherein it was decided that for ALD (E) and ALD (W), there will be a common Dy.PM/HR under administrative control of CPM/ALD (W) and the resultant surplus from KKK, MTC, Mum(N) & Allahabad will be used for four posts already filled in CO.



 In this regard, it is mentioned that while considering the last extension of tenure of Shri R S Mishra from 13.03.2020 to 12.03.2021, GGM/HR remarked as under:-

"There are 31 posts sanctioned for HR department against which 30 employees /retired employees are already working. One post has been advertised for Mumbai North has already been advertised to be filled on regular basis.

As all the HR field staff is required to be proactive in handling SAP and digital systems, issue was discussed with GGM/Shri Om Prakash in Dec, 2019 before issue of advertisement. One of the best employee form NCR was persuaded to apply for the post and he has now been posted in ALD(W). The candidate Sh. Deepak Gupta has been persuaded only because he is very good in handling data system and has good knowledge of computer."

- 2.1. The then M.D agreed to the above remarks of GGM/HR and ordered to take action accordingly (CP-19)
- 3. Thereafter, the file was called by the then Director/P.P. and recorded remarks/recommendation as under:

"File called. Earlier file was not routed through me. There are two units at ALD/E and ALD/W. As per policy one officer of HR is to be posted in each unit.
