

Ref: Your letter no. 2021/HQ/Admin/RTI-25 dated 14.01.2021

Vide letter in reference, RTI application dated 13.01.21 of Ms. Chandrawati Devi has been forwarded. In this connection, point-wise reply is as follows:

1. R&R award has been prepared as per Entitlement matrix dated 13.06.2011 approved by Railway Board for Dedicated Freight Corridor Project based on Railways Amendment Act-2008 and National Rehabilitation and Resettlement Policy-2007.
- 2, 3 :- Question is not clear. R&R award has been made as per the approved policy as mentioned at sl no. 1. Various reliefs of R&R as mentioned in the Entitlement matrix have been given to the eligible PAPs. So, question of deduction doesn't arises. It is further submitted that under DFCCIL /Mughalsarai (DDU) unit, land for DFC has been acquired in the district of Chandauli (UP), Kaimur (Bihar), Rohtas (Bihar) and Aurangabad (Bihar). Accordingly R&R award of PAPs have been prepared. Disbursement of the same has been made by the concerned Competent Authority of State Govt.
4. Reply same as Serial no.1.
5. Question not specific. However, it is pertinent to mention that R&R microplan has been prepared by an NGO engaged for implementation of Resettlement plan for EDFC under Mughalsarai unit.

This is also submitted that applicant had initially submitted RTI request regarding payment of training assistance to her which was forwarded vide your letter no. 2020/HQ/Admin/RTI-656 dated 31.08.2020. And reply to the same was already submitted vide this office letter no. MGS/EN/RTI/77 dated 09.09.2020.
