Sub: Eligibility conditions for selection of Tower Wagon Driver

With commencement of train operations on trial basis and as maintenance phase is also expected to start shortly, Tower Wagon Drivers will be required for operations of Tower Wagons.

The eligibility criteria for selection of Tower Wagon Driver will be as under-

- 1. Junior Executive (N5-N7) from Electrical / Mechanical / S&T department.
- 2. Minimum one-year regular service in the category of Jr. Executive from (Electrical/Mech./S&T) or above with good service record.
- 3. The candidate must be minimum ITI in any discipline.
- 4. Candidate should be fit in medical classification of A-1 at the time of his regular appointment or submit his fresh medical fitness in A-1 along with his application.
- 5. Junior Executives (N5-N7) from Electrical (TRD) shall be preferred.
- 6. Candidate having heavy Motor Driving License will be preferred.
- 7. Assistants Loco Pilots (N5-N7) can also be considered for posting.

Cadre section may take further necessary action as per the above for current postings and future postings as and when required.
