Application of Shri Gaurav Kumar, R/o Delhi, under RTI Act-2005

Gaurav Kumar has submitted an appeal against reply to RTI No. 342 on the ground that details not provided. The original RTI and reply given on the basis of available information on the date of reply i.e. as follows:

Information Sought For:	Proposed Reply/Remarks
My rank in my community (SC). Roll No. 20025070139, post- Jr. executive/Electrical.	Category wise separate merit list is not maintained.
Out of 68, how many candidates have been finally called for training in first list of Jr. Executive/Electrical.	Candidates have not been called for joining/training so far.
How many more candidates (standby list of Jr. Executive/Electrical) will be called for document verification and medical test in addition to above candidates?	The details will be available only after joining of candidates selected in the result.
Complete list of candidate's up to rank 276 with roll number and community.	Details of every candidate about his marks and position in combined merit list has already been conveyed. The information sought does not serve any public interest as per section 8(j) of RTI Act.

The applicant has preferred an appeal on the ground that details have not been provided. In this regard, it is submitted that Jr. Executive (Electrical)'s training was scheduled on 24.06.2019, accordingly the candidates were called for joining on 21.06.2019. Now the reply of original RTI item No. 2 & 3 are as under:


S.N	Information Sought For:	Proposed Reply
2.	Out of 68, how many candidates have been finally called for training in first list of Jr. Executive/Electrical.	Out of 68 candidates of main panel, total 27 candidates, who were found eligible in document verification and also found fit in Pre-Employment Medical Test were called for joining. Out of these 27, only 19 candidates have joined DFCCIL as Jr. Executive (Electrical). 01 Candidate Sought Extension. 07 candidates not reported for joining. Apart from above, 07 Ex-serviceman candidates are yet to join as their case referred to DGR for confirmation. 05 candidates were found medically unfit. Medical status has been sent to the candidates to appeal for re-medical.
3.	How many more candidates (standby list of Jr. Executive/Electrical) will be called for document verification and medical test in addition to above candidates?	Candidates of respective category from combined merit list will be called for in case of any shortfall from the main panel.

In view of above facts, if approved, reply on the above lines may be furnished to the applicant. Since this is an Appeal, the same is required to be sent to Appellate Authority, GGM/Admin. through concerned GGM/GM.
