I had been shortlisted for interview for the post of DGM(S&T). Further, I want to confirm the selection procedure as per DFCCIL HR manual, as publish for immediate absorption for other vacancies, is same as given below:

- a. Short listing procedure of eligible candidate: The applicants fulfilling all the eligibility conditions will only be considered for short-listing them for interview. However, in case of large number of applicants found eligible, DFCCIL reserves the right to shortlist only the limited number of candidates based on their relevant and required qualifications/additional professional qualification/experiences and other achievements.
- b. Selection among shortlisted candidates: Selection of the eligible and shortlisted candidates shall be based on interview and assessment of APARs for the preceding four years. The weightage will be given to various attributes in the interview as indicated below:

APARs 25 Experience profile 40 Additional professional qualifications 20 Personality, aptitude, General Awareness 20 Comm. Skill 15 **Oualifying 60%**
