In reference to above noted subject, Pointwise remarks, on information sought under RTI application under reference- I above are produced here below for further action.

- 1.0- Physical work against the said ROB with is completed and the ROB is opened to traffic on dated 12-04-2024.
- 2.0- The area of RE wall for the said is 1801 sqm. M/S SMB-GC(JV) contractor (40G, Siddharth Enclave, Mau Road, Agra, U.P.), DFCCIL client (office at New Tundlka DFC station, Vill-Bhakti Ghari) and M/S RITES (New Delhi) is DFC design consultant. No independent consultant associated with the RE wall Approaches.
- 3.0- The Work is awarded to M/S SMB-GC(JV) No specialized RE Wall agency engaged by DFCCIL. M/S RITES is DFCCIL design Consultant. RE wall proposal submitted by contractor to M/S RITES FOR PROOF CHECKED.
- 4.0- The requested information would harm the competitive positions of the third party including our suppliers vendors, contractors, purchased and customers. Therefore, this information cannot be provided under Section 8 (1) (d) & 11 of RTI Act.
- 5.0- As per contract clause, the execution of RE wall is in the scope of contractor. DFCCIL has not engaged any specialized agency for the same. Work has been carried out as per contract agreement. For the balance part of request, information would harm the competitive positions of the third party including our suppliers vendors, contractors, purchased and customers. Therefore, this information cannot be provided under Section 8 (1) (8g, 8j & 8d) of RTI Act.
- 6.0- The work has been carried out as per design submitted by contractor & proof checking by the consultant. Further testing will be done as per requirement.
- 7.0- The work has been carried out as per design submitted by contractor & proof checking by the consultant. All the related documents against the questioner asked are available in DFCCIL office field lab. The applicant may visit DFCCIL Tundla office and can see the documents in any working day, with prion intimation.
