**Text of Appeal**

Subject: Appeal for updated information and documents regarding land acquisition for Western Dedicated Freight Corridor Project. Respected Sir/Madam, We, the members of Vishant Regency Co. Op. Hsg. Soc. Ltd., located at Vasai East Gokhivare, Pincode 401208, are writing to you to express our dissatisfaction and concern over the land acquisition process for the Western Dedicated Freight Corridor Project that is affecting our society. We have previously requested certain documents and information regarding the land acquisition for the project and made a payment of Rs. 114 towards the processing fees. While we appreciate the documents provided, including the gazette notifications of land, acquisition of land survey, and desire copy of trees affected, we would like to emphasize that these documents do not address our current concerns regarding the A and B wings of our society, which are going to be acquired. We kindly request you to provide us with the following updated information and documents pertaining to the A and B wings of our society: 1. Notifications: - Please provide us with the latest notifications related to the land acquisition process for the Western Corridor of the project, specifically highlighting the acquisition of the A and B wings. 2. Alignment Changes: - We seek clarification on any alignment changes that have occurred or are proposed for the project, specifically addressing the impact on the A and B wings of our society. 3. Valuation Report: - We require an updated valuation report conducted by DFCCIL for the A and B wings, considering the current market rates and valuation methods. Please include the compensation amount for the acquired land, structures, and trees in these wings. 4. Survey Report: - We note that no comprehensive survey report has been provided for the A and B wings in the previous responses to our RTI requests. We kindly request a detailed survey report focusing on the impact of the project on the land and structures within these wings. We understand that the acquisition of the C wing has already been completed and appropriate compensation has been provided. However, it is essential to assess the impact on the remaining A and B wings, which are going to be acquired, and provide us with the necessary documents. We kindly urge you to expedite the provision of these updated documents and information within a timeframe of 7 days from the receipt of this appeal. We believe that access to these documents is crucial for our society members to understand the implications of the project and make informed decisions. We appreciate your attention to our concerns and the payment made earlier. We hope that this time the provided information will be relevant and useful for our society members.
