

✓ Sub: Extension of currency of panels of various posts of Direct Recruitment against Advt. No. 11/2018.

CBT for various posts advertised vide Advt. No. 11/2018 was conducted in the month of November 2018 where 1.77 Lakh candidates had registered themselves and 1.25 lakh candidates had appeared in the CBT. Psycho Test for 800 candidates was conducted in Aug 2019 and PET for 4300 candidates for MTS post was conducted in June 2019. The Main Panel and Standby Panel for each post was approved by MD as per extant instructions.

2. The validity of the Recruitment Panels is one year from the date of approval. Beyond that, it can be extended with the personal approval of GM. The relevant orders of Railway Board is placed at SN- 96.

3. The recruitment process against Advt No.11/2018 has continued till March 2020, however, due to lockdown it was stopped. Further, for joining of candidates,

induction training slots are not available. For induction training of Direct Recruits, DFCCIL is dependent on Railway Training Institutes. Railway Training Institutes are being continuously requested for slots for Induction Training. The training Institutes are not able to operate on 100% capacity due to SOP being followed to avoid spread of Covid-19 pandemic and also they are prebooked with Railway recruits. As such, arranging training slots for DFCCIL direct recruits at Railway Training Institutes are difficult this time and it may take some time.

4. Earlier, recruitment of only Civil Engg was assigned to me but now recruitment of all the departments has been assigned vide Office Order No. 590/2020 dated 29.09.2020. On perusal of the files of Electrical, S&T & Operating, it has been observed that currency of the panels has not been extended, which has the validity of One Year. The details are as under:

7	MTS (Civil, Elect, S&T & Optg.)	07.08.2019	Currency was extended for 3 months i.e. upto 06.11.2020.	06.08.2021

The currency of the panel of MTS was submitted for extension of one year. However, the same was approved for 3 months with the remarks to put it up again for post facto approval on joining of MD. At the same time extension of one year to be processed.

5. In view of above facts, the panels for the posts of Executive (Elect.), Executive (S&T), Executive (Operating), Jr Executive (Elect.), Jr executive (S&T) and MTS (Civil, Elect., S&T & Operating) are submitted for extension of one year beyond their present validity, as mentioned in para 3 above.
