The matter was raised with HR, the information holding office who has defended their position. Information received in respect of other points is enclosed.



Information sought in specific format vide item no. 02 is not maintained, however, applicant can be provided the copy of promotion orders issued after 18.04.2017. Also, copy of extant Promotion Policy and further amendment thereon, as sought vide item no. 7, are given subject to deposit of requisite fee, as per RTI Act. 2005.</p> <p>2. With the above observations, the above appeal of Ms. Mishra is disposed off.</p>
