



महोदय,

मेरे द्वारा पूर्व मे न्यायिक कार्यों के सम्बंध में बिल सं०-1 लगायत 10 के भुगतान के सम्बंध में और विलम्ब होने पर सूचना अधिकार के अन्तर्गत सूचना मांगी गयी थी। जिस पर आपके विभाग द्वारा बिल सं० 6 दिनांकित 17.05.2021 व अन्य विलों के सम्बंध में विभाग द्वारा काटी गयी धनराशि के सम्बंध में गणना चार्ट(केल्कुलेसन चार्ट)मांगा गया था। जिस पर आप द्वारा आर०टी०आई० के उत्तर दिनांकित 06.09.2022 के माध्यम से कथित केल्कुलेसन चार्ट की फोटो कॉपी उपलब्ध करायी गयी किन्तु गणना का कोई तरीका नही वर्णित किया गया।

बिल सं० 6 के केल्कुलेसन से सम्बंध में स्वयं विभाग द्वारा 41,600 रु० की गणना की गयी, किन्तु अन्तिम जोड में उक्त 41,600 रु० के स्थान पर 31,200 रु० अंकित किये गये है। जिसका कोई कारण दर्शित नही है उक्त सम्बंध में मैंने स्वयं कार्यालय मे उपस्थित होकर श्रीमान् जी. को उक्त बिल गणना दिखाकर शुद्ध करने का निवेदन किया था और श्रीमान् जी ने कन्सल्टेन्ट से शुद्ध करवाकर अन्तर धनराशि दिलाये जाने का आश्वासन भी दिया था। किन्तु अनेक बार मौखिक रूप से स्मरण दिलाये जाने के उपरान्त भी न तो वास्तविक गणना चार्ट उपलब्ध कराया गया और न ही अन्तर धनराशि का भुगतान ही कराया गया। इसके अतिरिक्त अन्य विलों में भी अवैधानिक कटौती कर बिल रासोधित किया गया किन्तु कोई गणना चार्ट उपलब्ध नही कराया गया। कृपया उक्त सम्बंध में उचित कार्यवाही करते हुये विलों की अन्तर धनराशि दिये जाने की कृपा करे।




