02.	Kindly indicate the reasons and necessity for this decision to count such deputation period as residency period for promotion. The certified copies of the relevant proceedings leading to this decision may kindly be provided.	
05.	Kindly indicate if the changed provisions of deputation residency period as per Circular No. 04/2017 were applied in the successive promotions in DFCCIL till date. If not, kindly indicate was it due to error of omission or due to different interpretation of the provisions of residency period in this Circular at the time of those promotions.
