

**Sub:- RTI and Complaint from one Sh. Prem Raj S/o Dharam Pal Village Nacholi district Faridabad regarding non-payment of excavated earth from his plots procured for the work of DFC Project by sub-contractor of L&T, Sh. Pratap S/o Sh. Udaybhan.**

Vide RTI dated 09-06-2020 & 02-07-2020 (under ref-i above), Sh. Prem Raj S/o Dharam Pal Village Nacholi district Faridabad has sought information regarding excavation of earth by some sub-contractor of L&T from their plot/Khasra No.59//22, 65//2, 65//9, 65//1/2, 65//12/1 and 65//13/1 of village Nacholi, District Faridabad.

Further, vide complaint on CPGRAM (No. MORLY E 20200584 dated 12-06-2020), the land owner claimed that earth was excavated from his plots by sub-contractor of L&T, Sh. Pratap S/o Sh. Udaybhan village Rosuka, Teshil Fara, District Mathura (Mob: 8393064301) for the work of DFC Corridor in District Faridabad. **However, the said sub-contractor has not made payment to the concerned land owner for the excavated earth and has left the site.**

The above matter is serious and L&T (as main contractor) should look into the matter immediately and ensure that due payment to the concerned land owner should be made promptly by the agency. Accordingly, the action taken by L&T in this regard shall be updated to this office at the earliest.

Hence, you are requested to inform Contractor and ensure the payment of land owner with the information to this office.
