With Reference to RTI -523-

The claims were not pending for the past three months as claimed by the applicant. However, Point Wise Reply to the information asked for, under RTI Act, 2005, is stated below:

1. a) The claim for the month of April and June 2025 were received in Finance on 07.08.2025 and were returned to the applicant's department on 09.08.2025 due to some observations.
b) The claim for the month of March 2025 was returned on 19.07.2025 due to certain discrepancies in TA/DA Claims.
2. There is no delay in processing of admissible and correct claims.
3. The claims are approved by the applicant's Controlling Officer and then checked and processed by the Finance and the payment is made by Corporate Office- Payroll Section.
4. There seems need for any further steps to be taken to expedite processing of claims as claims are already processed in DFCCIL Offcycle instead of payment with salary at the end of the month like in other PSUs. The dates for offcycle payments are 5th, 10th, 15th and 20th of every month, which is already a well-established and timely payment process in DFCCIL.
5. It is already clarified at Point No. 4.
6. The discrepancies as mentioned and communicated through Controlling Officer of the applicant, already mentioned in Point No. 1.

The applicant has chosen RTI route for Internal matter despite the fact that for Employee grievance, there is already a well-functioning Grievance Redressal Process in DFCCIL.
