

Apropos above, Neeraj Koli R/o Ajmer, Rajasthan has represented under RTI Act 2005, whose reply is as under:

Sr.No.	RTI query	Reply
1.	The specific reasons why the above- mentioned routes/stations are not yet permitted for freight operations with a 25- tonne axle load, despite their connectivity with the WDFC network.	PAO(BRC) is Indian Railway Station which are capable of handing 22.5 tonne axle load, only, that's why inward/outward traffic from PAO(BRC) cannot be permitted.
2.	Whether any infrastructure upgrades, safety assessments, or policy decisions are pending that restrict the enhancement of permissible axle load on these routes.	Upgradation of IR routes pertains to Indian railways.
3.	The expected timeline, if any, for revising the carrying capacity to accommodate 25 tonne axle load operation on these routes.	Pertains to Indian railways.
