- 1) No land has been purchased from Govt. of Gujarat for the DFCCIL Project.
- 2) The Govt. land has been transferred to Indian Railway for the project. The amount decided, in order of collector Ahmedabad is under revision and rate of land may change.
- 3) Govt. of Gujarat vide Revenue Department resolution number BHRJ/1017/2263/A-1 has reviewed the price of Govt. of Gujarat land according to which valuation of Govt. land in Gujarat shall be at par with adjacent private land. The final calculation of Govt. land as per directives of latest circular dated 01.03.2019 is under process and shall be submitted in due course till it adheres final shape.

If applicant is not satisfied with the information provided, then if can inspect the relevant records of this office during the office hours of DFCCIL Ahmedabad unit.
