Sub: Applicability of Section 24 of RFCT-LARR Act, 2013.

Ref: DFCCIL letter No. HQ/LA/EC/Entitlement Matrix dated 15.6.2016.

In view of the opinion rendered by the Additional Solicitor General as enclosed along with DFCCIL letter referred above, Board (ME) has approved that the provision of Section 24 of the RFCT-LARR Act, 2013 is applicable to land acquisition of DFCCIL w.e.f. 1.1.2015 even though land is being acquired as per Railway Act, 1989.

2. It is noted from DFCCIL letter referred above that several Awards under Section 20F were issued by the Competently Authority prior to 1.1.2015 in the year 2013 and 2014. DFCCIL should, therefore, examine each case of delay where compensation in respect of majority of land holdings was not deposited in the account of beneficiaries despite award being issued by the Competent Authority and take suitable necessary action in case there has been a default before invoking Section 24 of RFCT-LARR Act, 2013.
