Whereas a contract agreement between DFCCIL (Employer) and M/s Beijing national Railway Research & Design Institute of Signal & Communication Group Co. Ltd., (Contractor) for the work captioned in subject line is in force with extended time of completion being 18.02.2021. The contract is being administered by M/s SYSTRA Mott MacDonald (JV) as PMC.

Whereas the contractor has been issued 10 nos. notices vide reference (iii) to (xii) under sub-clause 15.1 of GCC/PCC by Engineer. Even after issuing 10 nos. notices under sub-clause 15.1 of GCC/PCC by the Engineer, no compliance of the Notices has taken place.

The Engineer having convinced of the Contractor's failures and defaults under the contract, Engineer vide reference (xiii) recommended DFCCIL to take necessary action as per the provision in the contract to invoke notice to Contractor as per Clause 15.2 (Termination by Employer) of GCC/PCC for noncompliance of clause 15.1 of GCC/PCC by Contractor for notice issued to him to improve the progress of work and requested Employer for taking needful action in the matter.

Whereas Employer has issued 14 days notice for termination vide reference (xiv) in accordance with Clause 15.2 of GCC/PCC. Contractor replied 14 days notice vide reference (xv). PMC vide letter under ref (xvi) has reiterated its recommendation for termination of contract as per clause 15.2(a) of GCC/PCC and same was conveyed to contractor vide this office letter under ref (xvii).

And whereas the above and other correspondences of the Engineer including the replies submitted by the Contractor as of date, materials available on record, having been duly considered by the Employer and in the light of the same, the Employer hereby terminates this contract as per the terms and conditions of GCC/PCC Clause 15.2 (a) of the Contract Agreement.

Further, the Contractor is hereby also served with a notice to the effect that the work executed by them will be measured by the Engineer, for which they are directed to attend for joint measurement on the date and time as will be intimated in due course, failing which the work will be measured by the Engineer unilaterally in absence and the result of the measurement will be final and binding on the Contractor. The Employer shall also take such further action as is authorized under the General Conditions of Contract and Particulars Conditions of Contract and in particular for exercise of its right conferred under GCC/PCC Clause 15.2. (Termination by the Employer).

The course of action as mentioned hereinbefore and provided in GCC/PCC Clause 15.2, shall be without prejudice to the Employer's rights to take action under any other clause or sub-clauses of the contract and to realize any dues, losses and damages whatsoever under such clause or sub-clauses of Contract and under the Laws of Republic of India, as the case may be:
