Extension of deputation tenure of employees working in DFCCIL beyond 5 years.

Kindly refer to my D.O. letter dated 08.02.2021 requesting to consider the extension of deputation tenures of 09 officers in DFCCIL. In addition, proposals for extension of deputation tenures of two more officers were sent to Railway Board in May, 2021 and June, 2021. However, Railway Board, vide their letters under reference, have not agreed to the above proposals.

In this regard, it is submitted that DFCCIL has been given very stiff targets to complete Eastern and Western Corridors in various phases up to June, 2022. The progress of works has been severely hampered due to lockdown imposed by the Government to prevent the spread of COVID-19. However, efforts are being made to not only restore the pace of progress to pre-COVID times but also to make up for the lost time. Besides, considering the fact that DFC is dealing with Design, build lump-sum contracts based on FIDIC Yellow Book for the first time in Indian Railways, retention of experienced railway officials, particularly at higher and middle management levels, is of utmost importance.

In the light of Hon'ble MR's instructions regarding restriction in extension of deputation tenure, DFC had tried for filling up of these posts by advertising the vacancies or by permanent absorption. The permanent absorption is, however, stuck due to non-availability of permanent posts in the Level E7 and beyond. The proposal for creation of posts had been approved by Board of Directors of DFCCIL and was sent to Railway Board for approval in November, 2019. but the same is still pending for approval of DPE/MoR.

Due to the prevailing pandemic situation and stiff targets to commission the sections, it is becoming extremely difficult to relieve the experienced officers at this crucial juncture of Project. The requirement has been reviewed and scrutinized in details further.

In view of the above and to achieve the targets fixed by Ministry of Railways, extension of deputation tenure of these officers (list attached) may kindly be considered up to June, 2022.
